

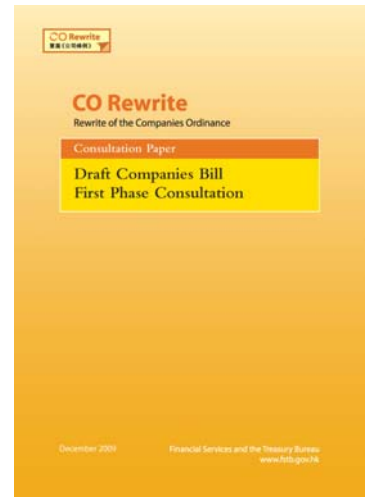
## Group Forum 專組論壇
