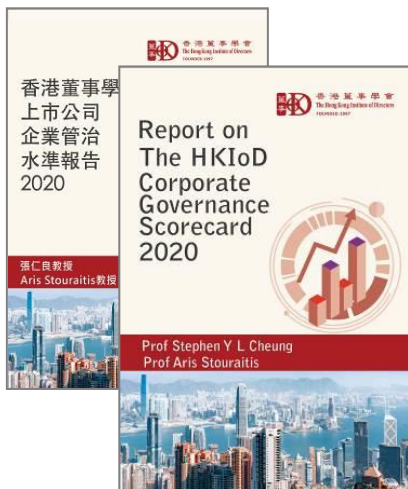


## 香港上市公司企業管治水準報告 2020 Report on the HKIoD Corporate Governance Scorecard 2020
