The Board Training Service of The Hong Kong Institute of Directors is an effective option to listed companies to arrange training for directors in order to satisfy the listing requirements for directors training every year.

香港董事學會（簡稱「HKIoD」）的「董事會培訓課程」培，專為上市公司安排而設，是符合上市規定董事每年接受培訓要求的有效選擇。

- Topics are generally 2-3 hours per session, which can be adjusted on requests. 每項培訓題目一般為 2-3 小時，可按要求調整。
- Course languages can be in **Cantonese, English and Putonghua**. 授課語言可以選用粵語、英語或普通話。
- **E-Learning** is available (convenient for mainland & overseas learning). 提供電子學習（方便大陸和海外學習）。
- Professional accreditation and provide CPD Certificates 專業認可「持續專業發展」課程。

HKIoD CPD courses are generally qualified to obtain accreditation from HKICPA, CPA Australia, ACCA, HKICS, Law Society of Hong Kong* and other institutes under Continuing Professional Development Alliance. Final decision is subject to approval from individual organisation and institute.
