I. HKIoD's Response to The Exchange's Consultation Paper on Listing Regime for Overseas Issuers 香港董事學會就香港交易所之海外發行人上市制度作出建議

HKIoD's on 31 May 2021 responses to The Exchange's Consultation Paper on Listing Regime for Overseas Issuers. The present consultation concerns proposals to reform and consolidate requirements as applicable to applicants who seek dual primary listing or secondary listing on the Exchange. Some of the proposals concern situations when dual listed Overseas Issuers have a majority of the trading of their shares migrate to the Exchange or de-list from the overseas exchange on which they primary list. This could affect whether and how the dual listed Overseas Issuers can continue to enjoy the Listing Rule waivers they may have been granted, or as applicable whether they can retain their non-compliant WVR structures or VIE struc-

## II. FRC Issues Its Annual Inspection Report 財務匯報局發布其年度查察報告

Financial Reporting Council (FRC) on 3 June 2021 (Thur) issues its Annual Inspection Report (the Report) which presents the full results of our inspections of listed entity audits in their first period of inspections from 1 October 2019 to 31 December 2020. During the period, the FRC completed 37 engagement inspections and 18 inspections of the quality control systems of listed entity audit firms.

### III. Further Reform of Regulatory Regime of Accounting Profession 會計規管 延續改革

Since the new regulatory regime has been operating smoothly, and the FRC has delivered a number of achievements, the Government will commence the next step of reform and further the independent regulation of accounting profession. FSTB proposes to expand the powers currently vested with the FRC, including inspection, investigation and discipline of PIE auditors, to cover all auditors.

The Government published in the Gazette on 18 June 2021 the Companies Ordinance (Commencement) Notice 2021, the Companies Ordinance (Commencement) (No. 2) Notice 2021, the Companies Ordinance (Commencement) (No. 3) Notice 2021, the Companies (Residential Addresses and Identification Numbers) Regulation, the Company Records (Inspection and Provision of Copies) (Amendment) Regulation 2021, the Companies (Non-Hong Kong Companies) (Amendment) Regulation 2021 and the Companies Ordinance (Amendment of Schedule 11) Notice 2021.
