I. Appointment Of Chief Executive by HKEX 香港交易所委任集團行政總裁

Hong Kong Exchanges and Clearing Limited (HKEX) announced on 9 Feb 2021 the appointment of Mr Alejandro Nicolas Aguzin (Nicolas Aguzin or Mr Aguzin) as Chief Executive of HKEX, effective 24 May 2021 for a term of three years until 23 May 2024. The Securities and Futures Commission approved Mr Aguzin will become an ex-officio member of the HKEX Board of Directors effective 24 May 2021.

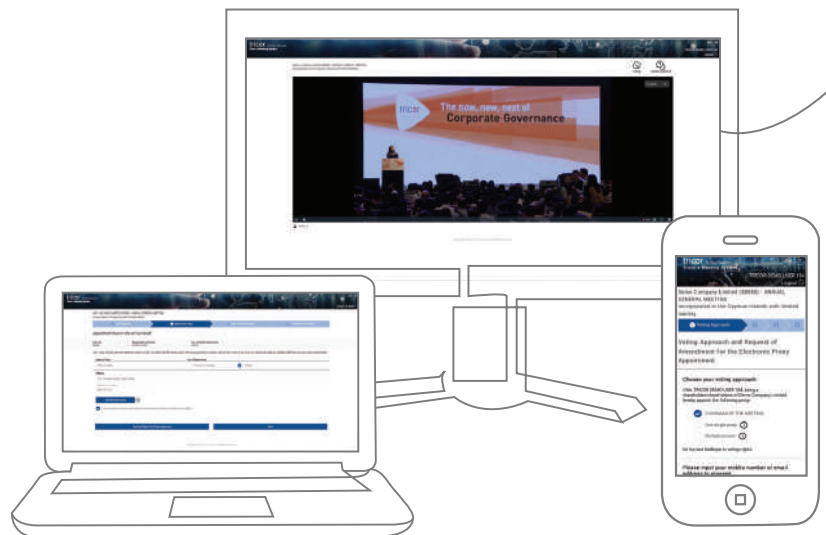

IV. FRC Issues Overview Of The Market For Listed Entity Audits In Hong Kong 財務匯報局發表香港上市實體審計市場概況報告

Financial Reporting Council (FRC) on 11 March 2021 issues its first policy and governance report on the Overview of the Market for Listed Entity Audits in Hong Kong (the “Market Report”), which provides high level insights into how competition operates in the market for listed entity audits in Hong Kong (the “Market”). It includes an analysis of the size and competitive structure of the Market, the relative significance of non-audit to audit services provided to listed entities by their auditors and how these factors have developed from 2010 to 2019. The Market Report can be accessed on the FRC’s official website – www.frc.org.hk.
