### Highlights of speech

Businesses in Hong Kong are protected by competition law if they come forward to make a complaint to the Competition Commission.

The Competition Commission has the role to play to ensure a fair form of competition. It is commonly repeated message that “Competition law is to protect competition not competitors”. When a powerful company engage in anti-competitive practices, it is not competition that brings this problem to the Competition Commission’s attention, it is either company’s competitors or customers. Not only Competition Commission is on businesses as well as consumers’ side, Competition Commission is most effectively when businesses and consumers are on their side too. To do this, businesses and consumers can help to take action against those who do not comply with law harming Hong Kong’s open and competitive economy.

Competition law and the Competition Commission are not solely on the side of consumers, they are on the side of businesses too. They are keen to hear from businesses that have suffered harm from anti-competitive conduct of others.
