<p>The Hong Kong Institute of Directors (“HKIoD”) grants membership grades to <i>individuals</i> according to the fulfilment of any <i>group of factors</i> in the right-hand matrix, including minimum (“min”) of: A = Total Work Years. Group Enrolment: Persons in a connected group (eg family, relatives, close friends) or members of the same organisation (though not of the same employer) joining at the same time may enjoy an offer of One-time Registration Fee at HK\$3,000 only for 5 persons.

- Annual Subscription Fee: Minimum HK\$9,000 for 5 members, \$1,800 for each addition, HK\$500 Elevation Fee for each "Fellow".
