

Mission, Vision and Values Statements of The Hong Kong Institute of Directors 香港董事學會「使命、願景、抱負」宣言

Mission 使命

The Hong Kong Institute of Directors ("HKIoD") is Hong Kong's premier body representing directors working together to advance corporate sustainability in creating long-term value for companies, their owners, stakeholders, humankind and Planet Earth through advocacy and standards-setting in corporate governance and director professionalism.

In furthering the above mission, HKIOD is dedicated to service in nurturing excellence in the following practices:

- Corporate governance ("CG"), which refers to the organisational framework, policies and procedures established by the board of directors to direct and control the company's behaviour and performance in order to foster the company's long-term success.
- **Director professionalism,** which refers to directors' fulfilment of the ultimate responsibility of corporate governance through proper practices, including, *inter alia*, the quest for continuing professional development.

Notes:

- (a) HKIOD perceives **corporate sustainability** as the purpose of all businesses. In promoting corporate sustainability, it is the board's responsibility to address ESG (Environmental, Social and Governance) pursuit in its CG agenda. ESG strategy embeds clear ethics anchored in sound CG, where the G in ESG is the overarching pillar. ESG and CG are mutually inclusive in discussions.
- (b) The following official guidelines are recommended by HKIoD: (i) *UN Sustainable Development Goals* (ii) *OECD Principles of Corporate Governance* (iii) Companies Registry *A Guide on Directors'* Duties (iv) HKEX *Corporate Governance Code* (v) HKIoD *Guidelines for Directors* (vi) *HKIoD Code of Conduct*.

香港董事學會為香港代表董事共同努力的首要組織,其宗旨是促進企業永續發展職能,為所有公司、其擁有者、持份者、人類以至地球創造持久價值;為達成使命,學會致力於企業管治及董事專業行為上的倡導及釐定相關標準。

在推進以上使命,香港董事學會提供專注服務,以培育卓越表現於下列實踐:

- 企業管治(或稱「公司治理」或簡稱 "CG"),指董事會制定組織框架、政策、程序等,以指引及監控公司的行為及業績,從而促進公司的持久成就。
- 董事專業行為,指董事肩負企業管治的最終責任,必須行為允當,包括但不限於追求持續專業進修。

- (a) 香港董事學會喻**企業永續發展職能**為所有企業之目的。在促進企業永續發展職能方面,董事會有責任在其 CG 議程中處理 ESG (環境、社會和管治)的奉行。 ESG 策略也融入了優秀 CG 的牢固信念,而 ESG 中的 G(管治)是總體的支柱。 ESG 和 CG 是相輔相成的討論議題。
- (b) 香港董事學會推薦下列官方指引: (i) 《聯合國永續發展目標》(ii) 《經合組織公司治理原則》(iii)公司註冊處《董事責任指引》 (iv)香港交易所《企業管治守則》(v)香港董事學會《董事指引》(vi) 《香港董事學會行為守則》。
