On Thursday, 8 Feb 2024, Financial Services and the Treasury Bureau published an article titled "Government launches consultation on legislative proposals to regulate over-the-counter trading of virtual assets", the Government launched a public consultation on legislative proposals to introduce a licensing regime for providers of over-the-counter (OTC) trading services of virtual assets (VA). The consultation will last for two months until April 12, 2024.
